As a condition of being admitted as a student of Aikido, we assume the risk of all injuries and do hereby hold neither the instructor nor Aikido Kids of Tamalpais and Samurai Summer Camp liable (including attorney's fees and costs) for all claims, actions or damages due to injuries suffered by me or caused to a third party by me during the course of training, or arising out of the activities involving Aikido or any variation thereof, whether occurring on the premises of the venue or elsewhere, excepting only those claims, actions, or damages caused by the gross negligence or intentional act or omission of them.

I understand that Aikido is an education system. For the benefit of the training and safety of myself and other participants, I agree to conduct myself in a manner consistent with a common sense of safety. To the end of ensuring safety to myself and others, I agree to explicitly follow the instructions of the teacher and understand that if I refused to do so, I may be asked to leave the class.
